Old Business:

St. Simons Island Public Library Returned Funds Proposal

Mr. Swecker made a motion to defer this business and it was seconded by Ms. Thomas. The motion passed unanimously.

New Business:

Institute of Museum and Library Services Media Content Authorization and Release

Ms. Mullis advised that she had been contacted by the Institute of Museum and Library Services to get permission to use our Liberty Ship photographs. Ms. Lafferty made a motion to approve the use of the photographs and sign the release. It was seconded by Mr. Martin and the motion passed unanimously.

Agreement with the St. Simons Island Library Support Fund

There was some discussion about the history of this agreement from 2007 amongst the trustees. There was also discussion that the St. Simons Island Support Fund had been represented during the strategic planning process. Ms. Campbell made a motion to accept the agreement and it was seconded by Ms. Thomas. The motion passed unanimously.

MOGL Board Chairs Proposal

Ms. Mullis presented the trustees with a design board of the color scheme and fabric to have the Sea Island and Jekyll Island chairs refurbished. There was some discussion about the timeline to have the furniture refurbished and if there would be any backlash if the furnishings were changed. It was agreed upon that as long as the Library had possession of the furniture the public was not tied to the particular upholstery. Ms. Lafferty made a motion to approve the refurbishing and reupholstering of the chairs. It was seconded by Ms. Thomas and the motion passed unanimously.

Library Facility Master Plan Proposal

Ms. Mullis reported that the concept for a master plan was approved back in July 2014. There was some discussion about the returned monies from Three Rivers and the money that would be available for the plan proposal along with discussion regarding the level of professional services provided in the plan. Ms. Mullis advised that Mr. Moore with McMillan, Pazdan and Smith Architecture would be here on October 13, 2014 for a presentation to the trustees regarding the plan. Ms. Campbell made a motion to approve the proposal to spend the \$2500.00 on Phase 1 of the plan. It was seconded by Ms. Burns and the motion passed unanimously.
